FINAL ORDER

2. ORDERED that the OED Director will publish the following notice in the Official Gazette:

5. ORDERED that the investigation be stayed until such time as _____ ordered by the Director of the USPTO to be reinstated to practice before the USPTO. Upon reinstatement, the Director of Enrollment and Discipline may take appropriate action with regard to the stayed investigation.
