MEMORANDUM AND ORDER

On August 23, 2023, Applicant Gilbert P. Hyatt. ("Applicant") filed "Requests for Extensions of Time" ("Requests") to extend the time to seek judicial review of the Patent Trial and Appeal Board ("Board") decisions in Application Serial Numbers 08/434,424, 08/470,856, 08/471,138, and 08/419,585. A table of the relevant information for each application number is listed below.

The Requests here—filed in writing before the expiration of the period for filing any of the appeal notices—fall under the "good cause" provision of 37 C.F.R. § 90.3(c)(1)(i). Under 37 C.F.R. § 90.3(c)(1)(i), the Office may, for good cause, extend the time to seek judicial review of a Board decision. Upon consideration of the

Requests for Extension of Time under 37 C.F.R. § 90.3(c)(1)(i), it is ORDERED that the Requests are GRANTED for the reasons set forth below.

Applicant has good cause for an extension of time for each of the underlying applications. Applicant anticipates filing a Section 145 action for each of the applications and he has a conflict between each application's due date for appeal¹ and an upcoming prosecution laches remand trial ("trial"), which is scheduled for the period between September 18 and October 6, 2023. *See* Req. at 2. Applicant asserts that preparation of each Section 145 complaint "requires the substantial personal participation" of Applicant but that Applicant "expects to be unable to devote sufficient attention to these matters … because of his need to prepare for and attend the [] trial, at which he will be a witness." *Id.* Applicant further explains that his attorneys will also be tied up with the trial and unable to devote time to the preparation of each Section 145 complaint. *Id.* The Office agrees that these reasons provide good cause for the extension Requests.

<u>ORDER</u>

Upon consideration of the Requests, it is ORDERED that the Requests are **granted**. Applicant's deadline to file a Section 145 action for each of the underlying applications is extended in accordance with the chart below.
